Checklist for Application to Change Street Name

This checklist is designed to help you make sure that you submit everything that is required for a complete application to change the name of a street within the City of Yazoo City and that you fill out the application form completely. Applications that are complete and submitted to the City Clerk's Office by 12:00 P.M. on deadline day will be processed for the next scheduled Board of Mayor and Aldermen meeting. Incomplete applications will be rejected and returned to the applicant and <u>not</u> placed on the agenda. Close attention to the checklist will help avoid a delay in your case being heard by the Board of Mayor and Aldermen.

Have you included the current name of the street you wish to have renamed? And have you include the proposed street name? HINTS: The proposed name cannot duplicate another street name unless in line with that other street. The proposed name usually should not closely approximate another street name.	ess it
Have you included the location of the street whose name you wish to have changed? This may included the affected addresses, intersecting street names, a list of the subdivisions through which the street passes, etc. A drawing or copy of a map or subdivision plat will be helpful. Have you listed the reason or reasons why you believe the street's name should be changed? You nattach a separate sheet if you need additional space. (Changing a street name requires address changes for all busines)	nay
Have you listed the name, address, telephone and fax numbers of the person who staff can contac questions?	t with
Have you attached a petition with the names and addresses of property owners and tenants whose property is addressed on the street you wish to rename and who support this request. This will be helpful for you to know how much support your proposal has. **The name change will have little chance of approved if many owners or tenants are opposed. Must have 65% of property owners affected by the change to sign.

\$250.00 application fee for processing request

\$150.00 fee for each sign to be changed per each street intersection shall be paid upon approval of any naming or name change of a street or public facility.

**Any costs associated with notice, advertisement, publication and all other fees or costs associated with processing petitioner's application shall be borne by the petitioner.
